1. Once application is reviewed and approved, you will receive a contract to sign and complete. Payment must be submitted with signed contract. Payments can be accepted over the phone if paying with a credit card (Visa, MasterCard, Discover or American Express) at 480-312-8506. Check payments can also be accepted. Registration is not complete until contract and payment have been received.
2. Exhibitors are responsible for their own booth setup and tear down. You must occupy your space by 7:30 a.m. the day of the event or you will forfeit your space. Your booth must remain open until 1 p.m. This is strictly enforced.
3. Exhibitors are required to park offsite at either the Scottsdale Plaza Resort or St. Barnabas Church. This is strictly enforced.
